Detail of Service Delivery Procedures

- Lodging application by follow TD. 64 form to chief of provincial land office or chief of branch land office together with map of the land asking for permission (conducting map to attach with application shall follow Ministry of Interior letter Most Urgent No. MOI 0511.3/circulation 1046 dated 25 March B.E. 2547).
- Official investigates matter of fact, reason of asking in detail under TD. 66 form.
- Applicant pays the expenses.

Official who received application or assigned official or representative of local administrative organization responsible the area of the land asking for permission goes to such land for verifying and investigating under TD. 67 form.

In case of considered that such land shall not be permitted, inform provincial land office within 5 days.

Detail of Service Delivery Procedures

In case of considered that such land shall be permitted, official prepares and post notification in disclosure area at district office or sub-district office or provincial land office or branch land office, sub-district headman office, local government organization office and the land area that asking for permission 1 copy for 1 place. (Notification under the law: 30 days including duration of making notification: 10 days).

- Asking for comment from council of local administrative organization.

- In case of there is no objection or trouble, land office that received application send the case and explanation to provincial land office (3 days)
- In case of there is objection or trouble, land office that received application investigate, consider and report to provincial land office (10 days)

Provincial sub-committee of consideration sand suction permission verifies area and meeting to consider for giving comment and proposing to provincial land office in order to completely conduct as meeting resolution before compile the case and send to Department of Lands for proposing to committee of consideration sand suction permission.

- In case of giving permission, applicant lodges application to receive license within 30 days since the date of knowing resolution of giving permission, with license from relevant government agency.
- When provincial land office verified license from relevant government agency completely, provincial land office shall issues license and inform 30 days land office that receives application/applicant.

Fee

- 1. Application fee: 5 Baht/parcel
- 2. Notification fee: 10 Baht
- 3. Person who received permission to conduct sand suction shall pay yearly remuneration to local government organization where the land is located under method and rating prescribed in local legislation but shall not exceed the rate attached at the back of the Land Code (28 Baht/cubic meter).

Resolution of committee of consideration sand suction permission is administrative order, applicant is able to prosecute to administrative court within ninety days since the date of knowing or should know the reason of prosecute according to Establishing Administrative Court and Administrative Procedure Act B.E. 2542.
