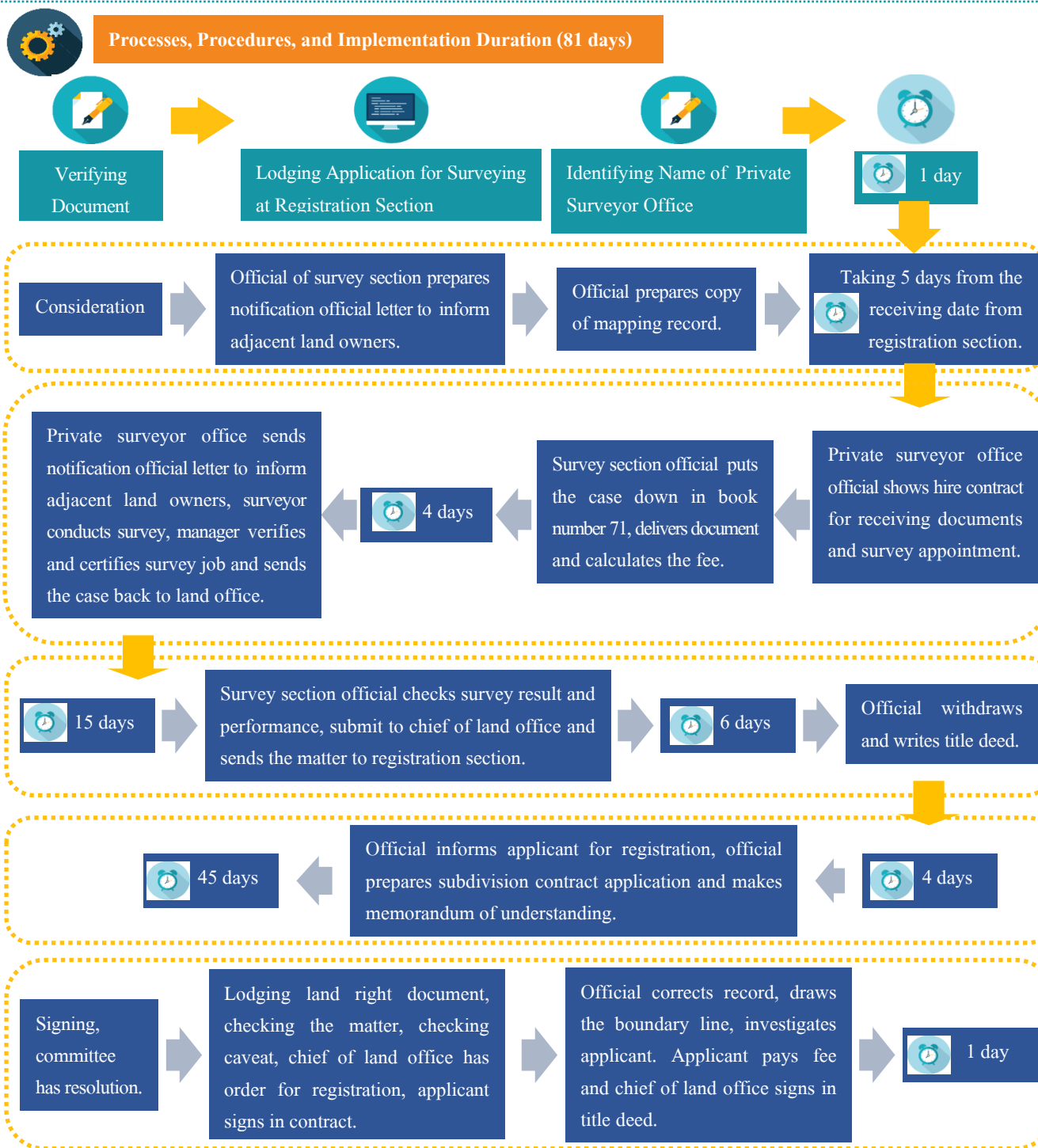

Fee

- Survey fee is under the agreement between applicant which is employer and private surveyor office which is employee.
 - Baht
- Fee for making duplication of document: 5 Baht/page
- Fee for certifying copy of document: 10 Baht/package



Duration Prescribed By the Law

- Duration is due to hiring contract for conducting land survey.

Document for Lodging Application

Document confirming authentic issued by government agency

- **Natural person**
 - Identification card
 - Household Registration
 - Title deed
- **Juristic person**
 - Minutes of the meeting
- Proxy with copy of identification card and household registration of proxy and attorney (if any)
- Evidence of changing first name or surname, Marriage certificate, Divorce certificate (if any)
- Evidence of consent or permission from agency.
