Subject: Registration for Verifying Juristic Person Information of Department of Business Development from Government Data Exchange Center System (GDX)

Refer to Department of Lands' Most Urgent Letter MOI No. 0515.3/Circulation 25970

As referred to the above - mentioned letter, Department of Lands has sent Department of Lands Announcement on Cancellation of Requesting for Copy of Identification Card, House Registration, or Juristic Person Certification for Conducting Transaction at Land Office throughout the country. In the mentioned announcement, competent official is prohibited to request for copy of identification card and copy of house registration or copy of juristic person certification to attach with application of registration of rights and juristic act and other transactions concerning with immovable property.

Digital Government Development Agency (Public Organization) has developed Government Data Exchange Center (GDX) system for the purpose of connecting information between department of lands and department of business development, for facilitating to agencies and people, including development the system for using in land office which using system of Land 2007, Land 2009 and Land 2012. The system is able to verify juristic person information already. Therefore, provincial land office/branch/sub - branch/district which using system of Land 2007, Land 2009 and Land 2012 shall proceed as follows:

1. Investigator of registration section and officer who using juristic person information register for working via e - Authentication Service for Citizen (OpenID) of User of Digital Government Development Agency (Public Organization). (As detail of attachment 1.)

2. Studying people guide for using system of Government Data Exchange Center (juristic person information) for Government Data Exchange Center (GDX) user to verify electronic juristic person information via the system. (As detail of attachment 2.)

3. Informing list of registering officer to Information Technology Bureau for approval of rights accessing to using the system within 21 December B.E. 2561 (2018). (As detail of attachment 3.)

Please be informed accordingly and inform provincial land office/branch/ sub - branch/district which using program of Land 2007, Land 2009 and Land 2012 to perform afterwards.
