Subject: Accessing to Juristic Person Information that Registered for Establishment with Department of Business Development via Connecting Information System.

Dear All Provincial Governor,

As referred in number 1, Department of Lands informed competent official in 73 land offices, that are part of the Project of Land Information System Development phase 1 which Department of Land has already established the system that connected electronic information with Department of Business Development, to access to juristic person information that registered for establishment with Department of Business Development via mentioned connected information system for every transaction, though, such juristic person wishes to present related document of such juristic person to competent official. For other land offices that are not established such system that connect juristic person information, when Digital Government Agency (Public Organization) (Currently, Digital Government Development Agency (Public Organization)) completely develop the system to capable of connecting juristic person information in the next phase, land office that has such connected information system shall access to electronic information for every juristic person transaction. And, as referred in number 2, Digital Government Development Agency (Public Organization) has already

established Government Data Exchange Center (GDX) for land office that use Land 2007, Land 2009 and Land 2012 to be able to check for juristic person information from Department of Business Development, official who conduct investigation of registration section and official who need to use juristic person information have to register for logging into the system and inform the name list of official who registered to Information Technology Bureau of Department of Lands within 21 December B.E. 2561 (2018) in order to approve the right to access to such system.

Department of Lands would like to inform that accessing to juristic information via such system for registration of right and juristic act or other transactions, and performing duty of land office are aiming to increase efficiency in delivering service and facilitate people. Therefore, Department of Lands has informed competent official to study and understand the handbook of Government Data Exchange Center (GDX) to be able to perform correctly. When official is approved to access to GDX system, every land office shall use such system to access to juristic person information which started since 2 January B.E. 2562 (2019)

Moreover, in the process of connecting such system and for conducting the service to be in accordance with measure of facilitating and decreasing burden of people according to digital government policy, chief of provincial land office/branch/sub-branch and chief of Bangkok Metropolitan land office/branch shall monitor official to strictly performing duty as the Department of Lands letter. In case of any obstacle in accessing to the system, please contact official of Information Technology Bureau to urgently solve the problem.

Please be informed accordingly and notify competent official to perform afterwards.
